Enable the evaluation and refinement of sustainable policies and strategies through regular reporting.

#### **Demonstrate Leadership:**

Position PAU as a role model in Palestine and the region by showcasing its commitment to global SDG initiatives.

#### Scope:

This policy applies to all units, departments, and stakeholders within PAU involved in activities related to the Sustainable Development Goals. It encompasses:

- 1. Preparation of detailed SDG progress reports reflecting the university's efforts in education, research, and community outreach.
- 2. Publication of reports targeting diverse audiences, including students, staff, local communities, and international partners.
- 3. Establishment of mechanisms to track and evaluate SDG-related initiatives and integrate findings into future plans.

#### **Statements:**

PAU is committed to fostering a culture of accountability and transparency by regularly reporting on its contributions to the SDGs. These reports will serve as a testament to the university's efforts in addressing local and global sustainability challenges, emphasizing its role as a leader in promoting sustainable development in Bethlehem, Palestine, and beyond.

#### **Procedures:**

#### 1. Establish a Working Team:

- Form a specialized team consisting of experts from both academic and administrative departments.
- Define clear roles and responsibilities within the team to ensure efficient implementation of SDG monitoring tasks.

#### 2. Collect Data:

- Gather relevant data from various academic and administrative units across the university.
- Use international tools and standards to ensure the data collected accurately reflects performance in relation to SDGs.

### 3. Analyze Data:

 Analyze the collected data using specialized software and techniques to maintain accuracy and consistency.

## 4. Draft Reports:

- Create comprehensive reports that summarize the collected data, analysis, achievements, and challenges.
- Ensure that the reports are in alignment with international standards for SDG reporting.

## 5. Review Reports:

- Conduct internal reviews to ensure the reports' accuracy, clarity, and consistency.
- Present the reports to university leadership for final approval and endorsement.

## 6. Publish Reports:

- Publish the approved reports on the university's website and social media platforms for public access.
- Share the reports with local and international partners to enhance transparency, build trust, and foster collaboration.

#### 7. Engage Stakeholders:

- Organize workshops and meetings with stakeholders to present the findings and engage in discussions.
- Collect feedback and recommendations from stakeholders to improve the university's future performance and impact related to SDGs.

### **KPIs:**

- Number of SDG progress reports published annually by PAU.
- ➤ Percentage of local and international stakeholders engaged through PAU's SDG publications.
- ➤ Increase in awareness of PAU's SDG efforts among the university community and local population, measured through surveys.
